# THE SCHEDULE OF APPROVAL

#### 1. PRODUCT DESCRIPTION:

#### "B-0 FIRE RESISTING LINING PANEL" model B25C

Composed of mineral wool panels type "KMD-Y-01", thickness 23 mm, density 150 kg/m<sup>3</sup> +/- 10 % (manufactured by New Adiabatic Material Production Factory of Nanjing Kangmeida, China) and 0.6 mm thick steel sheets, glued with PU adhesive tpe "TH-99", maximum application rate 180-200 g/m<sup>2</sup> (manufactured by Jiu Jiang Specific Adhesive Factory, China).

The non-exposed steel sheet was folded on one end in a 14x5.5 mm hook shape and panels were joined by inserting 14x12x14 mm " $\Pi$ "-type built-in strips into the hook.

The whole bulkhead panel was bound around with an enclosed frame made by steel angle (63x63x6 mm) and fastened by steel angles (63x63x6 mm).

Panel size: 2500 x 600 x 25 mm.

#### 2. DOCUMENTS AND DRAWINGS:

As per the Manufacturer's drawings N° 354CYC93-00SY, N°Q/CYC02.432-2001, N°Q/CYC02.432.1-2001, Q/CYC02.430-2001, Q/CYC02.430.1-2001Q/CYC02.470-2001, all dated 15/03/2012.

#### 3. TEST REPORTS:

Test report FT12143 dated 12/07/2012 as per IMO FTP Code Annex 1 Part 3 [test standard : IMO Resolution A.754(18)] from FEFTC, China.

#### 4. APPLICATION / LIMITATION:

- 4.1 The fitting aboard to be the same as used for the test.
- 4.2 Fire against the side without built-in strips.
- 4.3 The following component(s) shall comply with the requirements of the relevant Bureau Veritas rules and be type approved:
- the inslulation material "KMD-Y-01"
- the adhesive "TH-99"

## **5. PRODUCTION SURVEY REQUIREMENTS:**

- 5.1 The Model B25C products are to be supplied by CSSC CYMP (JiangXi Chao Yang Machinery Plant), JiangXi Chao Yang (Jiangxi) CHINA in compliance with the type described in this certificate.
- 5.2 This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.
